You must file a claim for a non-service-connected burial allowance within 2 years after the Veteran's burial or cremation. If a Veteran's discharge was changed after death from dishonorable to another status, you must file for an allowance claim within 2 years after the discharge update.

The surviving spouse of the individual may receive this deduction if the veteran was eligible at the time of their death. The surviving spouse may also receive this deduction regardless of whether the property was owned by the deceased veteran or by the surviving spouse before the veteran's death. Section 14.

Dependency and Indemnity Compensation (DIC) DIC is paid to surviving spouses, children, and qualifying parents of service members who died on active duty. This compensation may also be payable in cases where the service member died while on active duty for training, and even inactive duty training.
